AMERICAN JOURNAL OF INTERNATIONAL LAW
FOURTH ISSUE OF 100th VOLUME NOW AVAILABLE

WASHINGTON, DC—The American Society of International Law (ASIL) announces that the fourth and final issue of the 100th volume of its flagship publication, the *American Journal of International Law*, is now available. The *Journal* has been published quarterly since 1907 and, according to the online periodical resource JSTOR, is “considered the premier English-language scholarly journal in its field.” The *Journal* features articles, editorials, and comments by preeminent scholars on developments in international law and international relations. It contains summaries and analyses of decisions by courts and tribunals and of contemporary U.S. practice in international law. Each issue also lists and reviews recent books on international law.

The latest issue of the *Journal* includes the last set in a series of centennial essays in honor of the 100th anniversary of the *Journal* and of the Society. “The [*Journal*’s] Board of Editors asked a series of authors to look back over the previous century, consider how international law and our understanding of it have flourished and faltered—taking into account the role of the *Journal* as witness and participant over the years—and look ahead to the challenges facing us in the future,” wrote *Journal* Co-Editors in Chief Lori Fisler Damrosch and Bernard H. Oxman in their introduction to the 100th volume.

The current issue contains the centennial essays “International Economic Law and the *American Journal of International Law*” by Detlev F. Vagts; “The Evolving International Human Rights System” by Thomas Buergenthal; “Land Feuds and Their Solutions: Finding International Law Beyond the Tribunal Chamber” by Steven R. Ratner; and “The Territorial Temptation: A Siren Song at Sea” by Bernard H. Oxman.

Following these essays are the articles “Holding the Center of the Law of Armed Conflict” by W. Michael Reisman, and “The Costs of International Justice” by David Wippman.
