Disasters and the Role of the Sendai Framework for Disaster Risk Reduction 2015-2030

presented by: Professor Virginia Murray

The Disaster Law Interest Group is pleased to announce the second seminar in its 2018 webinar series.

The recent synchronous adoption of 2015 UN landmark agreements of the Sendai Framework for Disaster Risk Reduction, Sustainable Development Goals (SDGs) and COP21's Paris Climate Conference has created a rare but significant opportunity to build coherence across different but overlapping policy areas. Taken together these frameworks make for a more complete agenda for building resilience which requires action spanning development, humanitarian, climate and disaster risk reduction areas with a shift away from managing crises to proactively reducing their risks. In order to respond efficiently to all of the agreements, effective use of best available knowledge, innovative thinking, leadership, coordination mechanisms and partnerships are vital. Synergies between policies, programmes and institutions need to be highlighted and supported by the alignment of actions with engagement of stakeholders at all levels, as well as the breaking down of traditional silos to be replaced by more integrated partnerships that reflect a more holistic approach to risk management and the development of well-informed policies and decisions across all countries.

Professor Virginia Murray is the Head of Global Disaster Risk Reduction for Public Health England. She has been much engaged in providing scientific support for the negotiations for and the implementation of the Sendai Framework for Disaster Risk Reduction. Prior to this she was appointed as Head of Extreme Events and Health Protection, Public Health England where she developed evidence base information and advice on flooding, heat, cold, volcanic ash, and other extreme weather and natural hazards events. Appointed as Visiting Professor in Health Protection, MRC-HPA Centre for Environment and Health, Imperial College and King's College, London (2004) Honorary Professor at University College London (2013) and Visiting Professor to the UNU International Institute of Global Health Security (2016) she has published widely.
