# 2008 Annual Meeting

The Lieber Society's 2008 annual meeting was held at the Fairmont Hotel in Washington, D.C. at 8 pm on Thursday, 10 April, during the ASIL Annual Meeting. It was attended by 20 members of the Society in person, and by your Newsletter Editor via "virtual reality". A list of attendees appears on page 4. In a test-run for future events, Dennis

Mandsager and I established a link between his MacBook in Washington and a MacBook in my head-quarters, allowing me to participate in the meeting, even though I was sitting in an office in Wellington, New Zealand; 8,744 miles and 16 time zones away!

The value of this exercise lies not so much in my participation in the 2008 meeting, but in its exempli-

fication of what the Lieber Society can do as a truly global community. Your committee stands ready to hear your suggestions for future events, both of the traditional kind and also events using technology to connect our U.S. based members with events abroad, and vice versa.

The meeting began with a useful exposition and discussion of the 2007 study conducted as a collaboration between the International Committee

of the Red Cross and the Washington College of Law, *Teaching International Humanitarian Law in U.S. Law Schools*. The study is available on-line at http://www.wcl.american.edu/humright/center/documents/IHLSurveyReport.pdf.

The presenter, Hadar Harris, invited members of the Lieber Society to volunteer themselves as experts in IHL to assist in developing programs of IHL



teaching in U.S. law schools.

Following this presentation, Dennis Mandsager gave a report on the year in review. While *Lieber Notes* has been revitalized, there are other areas where the Society can lift its game in respect of communications and outreach. ASIL External Relations Coordinator Sheila Ward suggested that members of the Society write ASIL Insights on subjects of topical interest within our area of expertise. There was also a discussion

of the best use of the ListServe (asil\_lieberig@lists.asil.org). The consensus view was that a balance always needs to be struck between cluttering members' inboxes and not communicating enough.

Dennis also led a discussion on future activities. He mentioned that, although the Lieber Society did not sponsor a panel during the 2008 ASIL Annual Meeting, it had been suggested that we could do so in 2009. In addition, it was suggested that the Lieber Society should arrange local events. Dennis tabled the issue of how the Society might raise the necessary funds to support such additional activities.

### Lieber Prize

The Lieber Society once again conducted the Lieber Prize competition, which recognizes an outstanding published work by a scholar or practitioner 35 years of age or younger. Mike Schmitt notes that "This was an exceptionally rich year, both in terms of quality and quantity." The winner was Dr. Eve La Haye, for her book *War Crimes in Internal Armed Conflicts* (Cambridge University Press, 2008). Dr. La Haye is with the Arms Unit of the ICRC.

Two other works were cited for excellence and will be recognized by the award of a Certificate of Merit.

# Introducing...

#### Dr Eric Myles, our new Vice Chair:

"Since 2006 I have been an adjunct professor of law in the University of Ottawa. Through the late 1980s and the early 1990s I participated in investigating and where appropriate proceeding against alleged war criminals who had entered Canada. In the mid-1990s I joined in an enquiry into the deployment of the Canadian Forces to Somalia. The law of armed conflict has been subsequently a recurring strand in my published works - present and future. I am a graduate of the University of Toronto and Oxford University and spent two years as a visiting scholar at Harvard University. I have belonged to the ASIL since 2007."



# Lieber Military Prize

The Lieber Society also conducted another Lieber Society Military Prize competition, which recognizes an exceptional law of war writing by an active duty, reserve, or retired member of the armed forces of any nation. This year the winner is Brigadier-General Kenneth Watkin, Judge Advocate General of the Canadian Forces, for his article "Assessing Proportionality: Moral Complexity and Legal Rules," which was published in the latest volume of T.M.C. Asser Press's Yearbook of Inter-

national Humanitarian Law. Two other works were awarded certificates of merit. They are:

- (1) Major Chris De Cock, Legal Advisor in the Belgian Armed Forces, for his article "The Use of Air Assets and Military Operations in Urban Terrain: Legal Constraints" (to be published in the Israel Yearbook on Human Rights); and
- (2) Commander Rob McLaughlin, Royal

Australian Navy, for his article "The Legal Regime Applicable to Use of Lethal Force When Operating Under a United Nations Security Council Chapter VII Mandate Authorizing 'All Necessary Means'."

## **Future Activities**

#### In 2008

The Lieber Society will co-sponsor an international conference with the Asia Pacific Centre for Military Law (APCML) in Melbourne in late October 2008 to mark the 60th Anniversary of the delivery of the Judgment of the International Military Tribunal for the Far East (Tokyo War Crimes Trial). The Tokyo Tribunal is under-researched relative to Nuremberg. Given that an Australian Judge presided over the Tokyo proceedings (there were no Australian judges involved at Nuremberg) and Australia undertook in excess of 300 national war crimes trials involving more than 800 Japanese defendants post-World War II (with no Australian national trials at all in the European Theatre after the war), the APCML considered it appropriate to hold the conference in Melbourne. The conference will certainly involve Japanese, Korean and Chinese colleagues, as the intent is to explore some of the untold stories of Tokyo and hear various regional perspectives on the issues. Although a Lieber request for ASIL funding was denied, APCML has agreed to co-sponsor the event in exchange for ASIL publicity of its occurrence.

We will explore mechanisms for additional activities that will involve a maximum number of Lieber Society members. We will try to identify low or no cost events. We will seek additional sources of funding in coordination with the ASIL staff.

#### Beyond 2008

We plan to propose panels for each annual meeting in the future due to the expressed interest on the part of current ASIL leadership in involving interest groups in the planning and conduct of the meetings.

As ASIL updates its web site and information sharing capabilities, we plan to improve the sharing of LOAC and operational law information among interest group members ASIL. We have identified a member with the requisite legal and technological expertise who will coordinate this effort.
